1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Great Basin National
3 Heritage Area and Mormon Pioneer National Heritage
4 Area Extension Act”.

5 **SEC. 2. EXTENSION OF AUTHORIZATION OF THE MORMON**
6 **PIONEER NATIONAL HERITAGE AREA.**

7 Section 260 of the Mormon Pioneer National Herit-
8 age Area Act (54 U.S.C. 320101 note; Public Law 109–
9 338; 120 Stat. 1807) is amended by striking “15 years”
10 and inserting “30 years”.

11 **SEC. 3. GREAT BASIN NATIONAL HERITAGE AREA.**

12 (a) DESIGNATION OF THE GREAT BASIN NATIONAL
13 HERITAGE AREA.—The Great Basin National Heritage
14 Route Act (54 U.S.C. 320101 note; Public Law 109–338;
15 120 Stat. 1824) is amended—

16 (1) by striking “the Heritage Route” each place
17 it appears and inserting “the Heritage Area”;

18 (2) by striking “along” each place it appears
19 and inserting “in”;

20 (3) in the subtitle heading, by striking
21 “**Route**” and inserting “**Area**”;

22 (4) in section 291, by striking “Route” and in-
23 serting “Area”;

24 (5) in section 291A(a)—

25 (A) in paragraphs (2) and (3), by striking
26 “the Great Basin Heritage Route” each place it

1 appears and inserting “the Great Basin Na-
2 tional Heritage Area”; and

3 (B) in paragraph (13), by striking “a Her-
4 itage Route” and inserting “a Heritage Area”;
5 (6) in section 291B, by striking paragraph (2)
6 and inserting the following:

7 “(2) HERITAGE AREA.—The term ‘Heritage
8 Area’ means the Great Basin National Heritage
9 Area established by section 291C(a).”;

10 (7) in section 291C—

11 (A) in the section heading, by striking
12 “**ROUTE**” and inserting “**AREA**”; and

13 (B) in subsection (a), by striking “Herit-
14 age Route” and inserting “Heritage Area”; and

15 (8) in section 291L(d), in the subsection head-
16 ing, by striking “IN HERITAGE ROUTE” and insert-
17 ing “IN HERITAGE AREA”.

18 (b) DESIGNATION OF GREAT BASIN HERITAGE AREA
19 PARTNERSHIP.—The Great Basin National Heritage Area
20 Act (54 U.S.C. 320101 note; Public Law 109–338; 120
21 Stat. 1824) is amended by striking “Great Basin Heritage
22 Route Partnership” each place it appears and inserting
23 “Great Basin Heritage Area Partnership”.

24 (c) EXTENSION OF AUTHORIZATION OF THE GREAT
25 BASIN NATIONAL HERITAGE AREA.—Section 291J of the

1 Great Basin National Heritage Area Act (54 U.S.C.
2 320101 note; Public Law 109–338; 120 Stat. 1831) is
3 amended by striking “15 years” and inserting “30 years”.
